

Lasting Powers of Attorney

A Power of Attorney is a legal document in which an individual gives another person or persons (the Attorney(s)) power to make certain decisions and to deal with legal formalities and documents at their direction or on their behalf.



Lasting Powers of Attorney

A Power of Attorney is a legal document in which an individual gives another person or persons (the Attorney(s)) power to make certain decisions and to deal with legal formalities and documents at their direction or on their behalf. Lasting Powers of Attorney also enable Attorneys to make decisions regarding an individual's health or care when they are no longer able to make those decisions for themselves.

If you do not have a Power of Attorney in place and you lose capacity to make decisions for yourself, an application to the Court for a Deputy Order is likely to be required which can be very expensive, take several months to be granted and can place a significant burden on the person appointed by the Court.

There are two types of Lasting Powers of Attorney:

Property and Financial Affairs Lasting Power of Attorney which allows your Attorney(s) to have authority to deal with property and finances as you direct while you remain able to deal with these matters yourself, and then to take over matters for you should you lose mental capacity to do so.

Health and Welfare Lasting Power of Attorney which allows your Attorney to make decisions about your heath and care matters on your behalf, only when you no longer have the mental capacity to do so yourself. This can include, if you so wish, the giving or refusing consent to life sustaining treatment in certain circumstances.
