## ***Residential Property***

We are accredited members of The Law Society's Conveyancing Quality Scheme. We handle sales and purchases of property - freehold, leasehold, commonhold, etc. Our work includes remortgages, transfers of equity, shared ownership, new build, equity release mortgages, right to buy purchases, planning considerations, rights of access, boundaries, shared obligations and service connections as well as the nature of ownership, inheritance considerations and third-party rights (e.g. mortgages).

## ***Long Residential Leases***

We have particular specialism in this area, acting for both landlord and tenants in connection with lease extensions. Our litigation specialist can also assist with service charge disputes as necessary and enforcement of lease provisions.

## ***Landlord and Tenant***

Whether commercial or residential, we can advise both landlords and tenants on new leases (long and short) and suggested terms, such as length, rent, repairing obligations and relevant legislation.

Additionally, we can advise on issues that arise under existing leases. This can include disputed areas such as rent and service charge arrears or claims for breach, dilapidations, forfeiture and possession; together with undisputed topics such as assignment, sub-letting and lease renewals.

## ***Company / Commercial***

We can advise on commercial matters, from ordinary sales and purchases, through to complex land development and arrangements. We also provide advice on business/company topics such as transfers of going concerns, Articles of Association, employment, re-structuring, terms and conditions of business, loan agreements and partnership and shareholder agreements. We also advise on business disputes.

## ***Wills***

When making a Will it is advisable to take advice from a qualified lawyer, to ensure your wishes are carried out. We can advise you on family succession, trusts and how Inheritance Tax affects you, and we look to advise on how your wishes may be better structured to make use of the allowances available to you.

## ***Lasting Powers of Attorney***

A Lasting Power of Attorney is a legal document which lets you appoint another person or persons (Attorneys) to make decisions on your behalf. There are two types; one for financial decisions and one for health care decisions. You can choose to make one or both and we can offer help and advice in respect of both types of Lasting Powers of Attorney.

## ***Trusts***

A trust arises where one person (a trustee) holds an asset for the benefit of another (a beneficiary).

A trust is a useful device for carrying out particular wishes but there can be complicated tax and other consequences. We can assist in advising on setting up trusts and in their ongoing management, including the completion of trust and estate tax returns if required.

## ***Administration of Estates***

Upon the death of an individual, it is necessary for their estate to be administered. We are able to offer several different levels of service from the preparation of the Probate documentation, including the Inheritance Tax forms and application for the Grant of Probate. Alternatively, we can assist with the full administration to include collecting in the assets and distributing the estate.

## ***Family Law***

We have a very experienced and dedicated team of expert qualified lawyers (Resolution members) specialising in divorce and finances, Civil Partnerships, unmarried couples (including separation and property disputes) and all matters involving children - to include residence (custody) and contact (access). Child Arrangement Orders (an Order determining who the child will live with and who the child will spend time with and how often and the type of Order which should underpin the arrangements), Prohibited Steps Orders (an Order preventing a party from exercising their Parental Responsibility) and Specific Issue Orders (an Order determining a particular question in relation to an aspect of Parental Responsibility). We also undertake Collaborative Law and advise on mediation matters. We focus on resolving matters quickly, favourably and cost effectively.

Our skilled lawyers are considered very personable and are highly motivated to ensure you receive a quality service. We offer a free 30 minute appointment to discuss your circumstances and give preliminary legal advice.

## ***General Litigation/Dispute Resolution***
